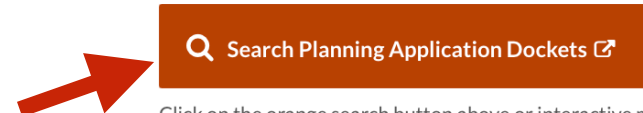
## DEVELOPMENT APPLICATIONS UNDER REVIEW
